  - b. **PLANNING COMMISSION REPORT:** Chairman Kippola went over the PC minutes to update the board. A copy of the full PC minutes are available at the hall.
  - c. **FIRE DEPARTMENT REPORT:** Trustee Koski gave a brief summary.
  - d. **ASSESOR REPORT:** Dylan Jurasin reported that there will not be a loss in revenue without holding a Truth in Taxation hearing. Land valuations did not pass the AMAR review, as well as small business exemptions. He also went over his corrective action plan.

- c. **Cemetery Services Proposals:** Chairman Kippola talked about the proposals and the next steps to take. He recommended contracting with Globe Printing to begin the document scanning process. He also discussed obtaining a couple more quotes from 2 other companies. He and Clerk Etelamaki continue to work on the project.
