We are excited to announce that we WILL be having a Christmas party again this year! The date will be December 11th from 1:00-3:00pm. Garbage & Recycling:

Humboldt's sanitation provider is North Country Disposal. Garbage and curbside recycling is picked up every Monday. Please have your garbage out by 6:00am. If you utilize one of the garbage sheds, please follow the rules so we can continue to provide the service. The recycling continues to be single stream with no glass allowed. Ishpeming Township does provide glass recycling on the first Wednesday of every month from 1-6pm. If you need Transfer Station Tickets, you can purchase them at the Hall during regular business hours. They are \$8 per ticket per 100 pounds. There is more helpful sanitation information at www.recyclego6.com. The Township will host 2 clean-up events taking place in June and September. More information will be available in the spring newsletter.

Cemetery News & Information:

This fall, the Board approved contracting with TriMedia to update our Cemetery records. They are working on providing a more accurate map as well as using ground penetrating radar to verify burial locations. We will also eventually have an avenue available on-line to look up headstones and information pertaining to our cemetery burials. We are excited for the final outcome and think it will be very valuable to everyone! The Board recently adopted a Cemetery Ordinance and there is helpful information within it. You can find it on our website or at the hall. We are undertaking this huge project to update our cemetery records and improve the process. We are asking anyone who may be interested in rescinding burial rights for un-used plots to please reach out to us. We have noticed through this project that there may be many plots that remain vacant, and our hope is to reclaim them for future generations to use. Please stop in for any questions or inquiries you may have about cemetery plots.

Road Improvements:

For the year 2022, the Board approved re-paving County Road FD and FJ. There will also be some new gravel on County Road FQ. We continue to make improvements where needed and as funds allow. If your road is one that is having work done, please be advised that between the prep and the final work, some significant time may pass. Your driveway details will not be completed at the same time as the main road. Rest assured, they will come back to smooth out the height differences, so please be patient.

Streetlights:

There are many streetlights located within the Township. From time to time the lights burn out. The easiest and fastest way to report an outage is to do it on-line. Simply go to www.we-energies.com/services/streetlight and you can zoom in on the map to pick the light that is out. It is very easy to do, and you get a confirmation email of your submission stating they try to fix them within 72 hours of reporting.

Winter Taxes:

Winter taxes are payable at the township starting December 1st through February 14th, 2022. Treasurer hours are Tuesday's & Thursday's from 10am-12pm. There is also an option to pay them online for a 3% fee. Just go to https://bsaonline.com/?uid=1466. After February 28th, 2022 taxes become delinquent and are turned over to the county treasurer.

Fishing Derby:

The Annual Children's Fishing Derby will be held during the DNR free fishing weekend which is slated for June 11th, 2022. Look for more information in the Spring.
